Dance Saskatchewan Incorporated (DSI) is inviting applications for the position of Executive Director. Established in 1979, DSI is one of the premier cultural and art service organizations in Saskatchewan and has a prominent place in the dance scene in Canada. With dance in Saskatchewan having a wide variety of practices, traditions, practitioners and audiences, DSI itself performs a challenging umbrella service for the community: advocating for dance; helping the community to meet its needs and aspirations; and, representing it within the SaskCulture community and at the Saskatchewan Lotteries Trust for Sport, Culture and Recreation as an eligible cultural organization.

In recent years, DSI has been moving from an organization with a strong emphasis on direct programming and localised service provision to one that seeks to respond to community needs on a truly province wide basis. Refocusing after an armslength Province Wide Review, the findings of which are available on the DSI website, the organization is poised to implement a revised strategic plan and realign its relationship to the entire dance community. Like all sectors of our society, dance has been significantly affected by the pandemic and DSI will have a major role in helping the provincial dance community to rebound and rebuild.

Executive Director

The successful candidate will lead the work of Dance Saskatchewan in advancing and promoting dance within and beyond the Province, helping to meet the diverse needs of the dance community and implementing the Board's response to the Review. The organizational challenges identified by the Board of Directors for the next 3-5 years for which the E.D. will be primarily responsible are province wide service, sustainability, risk management and governance.

- Team player and leader in an organization undergoing significant change.
